

This activity history proves that the identity has existed for a period of time and is being used in a way that meets normal expected behaviour. Evidence of an extended period of normal activity is a particularly good indicator that the identity is unlikely to be synthetic.

3. IDENTITY FRAUD ATTRIBUTES
